TITLE: Congregation House of Jacob fonds No.: CHJ

DATE RANGE: 1909-1984, predominant 1980-1983 **EXTENT:** 22cm of textual records. – 3 objects

ADMINISTRATIVE HISTORY:

Congregation House of Jacob, sometimes referred to as *Beit Yaakov* or Beth Jacob, was organized in 1907 and received its provincial charter as "Congregation of the House of Jacob" in 1909. Among the declared purposes of the new congregation were "to make donations to or otherwise assist any public charitable ... or useful Institution ... " and to "promote the extension of the Hebrew faith". A one-room structure was built at the back of a lot on 3rd St and 5th Ave E to serve as prayer hall and classroom while funds were raised to erect a permanent sanctuary, and services were led by members and short-term clergy, including Rabbi Hyman Goldstick, Rev. Hirsch Sosinsky, I. Kadushin, and Rev. Isaac Klegman. The founding president was Jacob Diamond; early presidents included Charles Malkin, J.A. Guttman, Jack Bercuson, J. Lukatsky, H.L. Epstein, Morris Groberman, E. (Yoel) Shapiro and John Hector.

In 1911 a 500-seat synagogue was constructed in front of the original building. The cornerstone, in Yiddish and English, notes the donations of Charles Bell, Alexander Bell, and Jacob Polsky. A *mikvah* (ritual bath) was built behind the synagogue. Services continued to be performed by congregation members and short-term clergy, including Solomon Roubin (Rubin), who was willing to work for the fees available to him from community and life-cycle events. The first long-term Rabbi was Rabbi Simon Smolensky who led the congregation from 1917-1935, and the congregation's longest-serving spiritual leader was Rabbi David Barenholz, from 1939 through 1968.

The congregation was responsible for *kashrut* (kosher) supervision for the Jewish community of Calgary and area, and over the years this function provided an important source of income, along with synagogue seat sales, membership dues and pledges for special occasions. In its early years the synagogue building provided a meeting place for many events and activities within the Calgary Jewish community, which had no other communal building until 1926. One of the Congregation's first projects was to organize a Jewish school, Talmud Torah, which soon became an independent organization. In 1980 the congregation established another school, Akiva Academy, which remained affiliated.

The House of Jacob building was sold to the City of Calgary in 1967, and demolished the following year to make way for urban renewal. The congregation moved to a smaller building at 12 Avenue and 12 Street S.W. and made several small amendments to the constitution. After that building was sold in 1979, the congregation met in a series of temporary locations, both rented and purchased. A move to revitalize the congregation resulted in extensive changes to the original constitution, including clauses specifying that the practices of the Congregation were to accord with "the tenets of Traditional Orthodox Judaism", and that female members would be allowed to participate in all voting. In addition, a resolution was passed to relocate the synagogue to the deeper south west quadrant of the city.

In 1984 Congregation House of Jacob officially became Congregation House of Jacob-Mikveh Israel. The new congregation incorporated the cornerstone from the 1911 House of Jacob synagogue into their building, and in some of their early unofficial documents refer to themselves as Congregation House of Jacob. They became the parent organization for Akiva Academy.

SCOPE AND CONTENT:

The fonds consists of minutes, financial statements, membership lists, deeds for synagogue seats, rabbinical contracts, land purchase and sale documents, correspondence and newsletters, as well as a book of psalms with the congregation's stamp, and 2 bricks from the foundation of the 5th Avenue Congregation House of Jacob synagogue building.

The fonds has been arranged into the following series: Governance; Minutes; Correspondence; Land Sales & Purchases; Financial; Membership; Events, Publicity and Mailings; Newsletters; Objects.

SCOPE AND CONTENT:

The series includes the following issues: 1979 August, Shavuot, Fall, Chanuka; 1980 Tu B'Shevat, Purim, Pesach, Shavuot, December; 1981 March, May, July, September, December; 1982 March, August, December; 1983 Passover, Shavuot, Rosh Hashanah; 1984 September
