ADMINISTRATIVE HISTORY:

Temple B'nai Tikvah was established in Calgary in March 1979 as the Calgary Liberal Jewish Congregation, and was incorporated by November of that year. Almost from the beginning, the congregation referred to itself as Temple B'nai Tikvah, though the name wasn't legally changed until August 1984. The first executive included Ron Bing (President), Norm Yanofsky (1st Vice President), Joel Fagan (2nd Vice President), Ben Ziv (Treasurer) and Judy Bing (Secretary).

Meetings, services and religious school classes were originally held in the homes of members, including Ron and Judy Bing, Arnie and Susan Slive, and Joel and Sandy Fagan. As the congregation grew, additional space was rented in a variety of places including public schools, libraries and community halls. In 1982 the congregation began leasing space at the Calgary Jewish Centre for bi-weekly services, renting larger spaces as required for High Holy Day services. The religious school rented space on Sunday mornings in various Calgary public schools before settling at Calgary Jewish Academy. Services were conducted by lay-leaders and student rabbis, who joined the congregation regularly throughout the year as well as for High Holy Days. Temple B'nai Tikvah hired its first permanent rabbi, Rabbi Jordan Goldson, in 1987.

Temple B'nai Tikvah undertook a major capital campaign and in 2004 arranged to purchase a church building in the neighbourhood of Britannia. They entered into a series of facility-sharing arrangements with the previous congregation that continued until Temple B'nai Tikvah took full ownership in 2007. The religious school was renamed Shabbat School and classes were moved to Saturday mornings.

Temple B'nai Tikvah programming places an emphasis on community service and social action. For many years the congregation regularly hosted a community shelter through Calgary's "Inn from the Cold" program, and volunteers serve lunch once a month at the Calgary Drop In Centre.

SCOPE AND CONTENT:

The fonds consists of minutes, unaudited financial statements, correspondence and membership lists from Temple B'nai Tikvah, as well as congregational history, program and event publicity material.
