### **ADMINISTRATIVE HISTORY:**

Congregation House of Jacob-Mikveh Israel, often referred to as HOJ-MI, became an entity in 1984. A move to revitalize Calgary's original Orthodox congregation, Congregation House of Jacob, had resulted in extensive changes to the original constitution, including clauses specifying that the practices of the Congregation were to accord with "the tenets of Traditional Orthodox Judaism", and that female members would be allowed to participate in all voting. In addition, a resolution was passed to relocate the synagogue to the deeper south west quadrant of the city. Some documents, particularly those related to fundraising activities for the new congregation's synagogue building, were written on Congregation House of Jacob-Mikveh Israel letterhead prior to its establishment.

The new congregation incorporated the cornerstone from the 1911 House of Jacob synagogue into their building, and in some of their early unofficial documents refer to themselves as Congregation House of Jacob. They became the parent organization for Akiva Academy, re-named the David and Tibele Halpern Akiva Academy in 2019.

HOJ-MI supports youth participation through National Council of Synagogue Youth (NCSY) (grade9 through high school youth group) and, when interest supports it, Machon (grade9 through high school study group), and has an active Sisterhood which hosts a wide range of events, including an annual Stampede Breakfast.

Congregational fundraisers have included Welcome and Farewell events (primarily for clergy), an 80<sup>th</sup> Anniversary Dinner (1989); an Annual Gala Dinner (inaugurated in 1995), golf tournaments, concerts, vehicle and other raffles, bingos and provincial casinos. HOJ-MI volunteers participated in the International Food Fair held at Olympic Plaza during the 1988 Winter Olympics, stocking and running the "Kosher Kiosk" food booth. The booth was set up again the following year as part of Calgary Winterfest. A soft-cover book detailing the congregation's history was published in 2009, in conjunction with HOJ-MI's Centennial celebration.

## **SCOPE AND CONTENT:**

The fonds consists of by-laws, minutes, financial statements, membership lists, rabbinical contracts, land purchase documents, correspondence, construction reports, ritual guides, programmes and publicity material, a ceremonial coin, commemorative book and newsletters.

### **ADMINISTRATIVE HISTORY:**

David and Tibele Halpern Akiva Academy was established as Akiva Academy in 1980. Generally referred to as Akiva Academy, the school began with a single kindergarten class and a mission to provide "excellence in education: commitment to Torah values". Rabbi Peter Hayman, then spiritual leader of Congregation House of Jacob-Mikveh Israel, served as the principal and Carl Bond was president. Space was rented at Bel-Aire School, and by 1982, when Rabbi Baruch Hilsenrath became Principal, the school had grown to 55 students in 4 grade levels. In 1997 Akiva Academy added a full Junior High (grades 7-9) class.

By 1986 Akiva Academy had signed a lease with the Calgary Board of Education and moved to an un-used school building on Haddon Road in the city's southwest, sharing the building with Calgary Preparatory School until 1989. It was originally hoped that construction on the land purchased by Congregation House of Jacob-Mikveh Israel in 1984 would include a school building, but that plan never materialized. In 2001 the decision was made to purchase the Haddon Road building, which was renamed The Israel Koschitzky Family Torah Learning Centre in honour of the foundation which provided the school with a permanent home. In 2019, a significant donation from siblings Shelley Zimmerman, Nelson Halpern and Jackie Halpern, in memory of their parents David and Tibele, resulted in the re-naming of the school.

### **SCOPE AND CONTENT:**

The series consists of the following textiles used by House of Jacob-Mikveh: deep-red velvet Ark curtain (43"x76") with fringed valance, inscribed in Hebrew with yellow embroidery "donated by the woman Rachel daughter of Yaakov Serot[?] 1912"; green velvet Ark curtain (58"x86") with separate fringed valance, inscribed in Hebrew with gold metallic embroidery "in memory of Yoel and Leah Shapiro ..." [late 1950's]; deep-red velvet, fringed Torah reading table cover (48"x36"), inscribed in Hebrew with yellow embroidery "donation of Peretz and Rivka Block to Congregation Beit Yaakov 1961"; white velvet Chupah [wedding canopy], inscribed in English with gold embroidery "In honour of Eliot and Minnie Zuckier on their 50<sup>th</sup> anniversary / with love and admiration from their children and grandchildren June 26, 1999".

The table cover was used by the congregation until the 1990s, the green velvet Ark curtain until c2000, and the Chupah until 2004.
