ADMINISTRATIVE HISTORY:

Camp B.B.-Riback was originally known as Camp B'nai B'rith, an undertaking of North-West Canadian Council B'nai B'rith. The main impetus for the creation of the camp came from M. Ted Riback, who was frustrated by both the difficulty of finding rental camp facilities for the Alberta and Saskatchewan Jewish communities, and by the often-run-down state of those facilities. He spear-headed a fundraising campaign -- with the support of Morris Hector in Calgary, and Mickey Dlin and Tevie Miller in Edmonton -- that provided for the 1955 purchase of waterfront property at Pine Lake, Alberta. Architect Jack Abugov drew up plans and supervised the camp's construction.

The inaugural session of Camp B'nai B'rith was in the summer of 1956, the same year that the North-West Canadian Council B'nai B'rith Camp Service League was incorporated. The structure of the camp included a Board of Directors made up of representatives from each of the B'nai B'rith Lodges in Alberta and Saskatchewan, and over the years the camp office has variously been located in both Edmonton and Calgary. Early camp directors were Ida and Aron Eichler (1956), Max Levie (1957), Lou Faber (1958), Chaim Kornfeld (1959-1962), and Bill and Rivvy Meloff (1963-1964). By the late 1980s B'nai B'rith had become increasingly removed from camp oversight, and the administration of the camp was restructured.

Campers have ranged in age from 5-13 years old, with Counsellor-in-Training and Leadership Training programs offered for older participants. Over the years, programming has included arts and crafts, horseback riding and Judaic activities, as well as team and individual sports. Physical improvements to the original property have included the construction of the Harry and Martha Cohen Swimming Pool, paved basketball and tennis courts, and the addition of insulation and heating to all camp buildings. A 1998 overhaul of the kitchens and other foundational structures was instigated by Ted Riback, and the camp was renamed Camp B.B.-Riback at this time. The touch-down of a tornado on the far side of Pine Lake in 2000 led to the construction of a new Arts & Crafts building, designed to provide extreme-weather protection for the camp and its neighbours.

The fonds consists of incorporation documents, financial statements, year-end reports, correspondence, in-house and commemorative publications, manuals and publicity material regarding Camp B'nai B'rith / Camp B.B.-Riback.
